
The Academy has sought the sparing of nominee judicial officers in terms of the following facts:

1. The instructions of Hon'ble Court as regards number of officers to be spared from one station has been adhered to, however, in view of the remaining number of training programme & the judicial officers, at some places the number may vary.
2. The nominee officers, who are under suspension or due to retire within a year from the date of the training or joined special post till the date of training programme, need not require to attend the training.
3. The officers who are going to retire within a year from the scheduled date of training need not attend the training. However, it has been requested to exclude the District and Sessions Judges from this criterion.
4. The nominee officers who have been designated as full time Secretary of District Legal Services Authority need not attend the training as long as they hold such assignment.
5. The officers whose place of posting are changed till the date of scheduled training due to Annual General Transfer / Mid Term Transfer, will have to report to the Academy for their respective courses from the new place of posting, as per the present schedule only.
6. The nominee judicial officers should not fix the record on their scheduled date of the training.

7. The participants have to report to the Academy on 09.30 A.M. sharp on due date of their training in proper dress.
8. The participants will be provided Hostel and mess facility.


