

1. The nominee officers, who are under suspension or joined special post as on the date to their training are not required to attend the aforesaid training.
2. The officers who are going to retire within a year from the scheduled date of training need not attend the training.
3. The nominee officers who have been designated as full time Secretary of District Legal Service Authority need not attend the training as long as they hold such assignment.
4. The officer whose place of posting are changed till the date of scheduled training due to Annual General Transfer/ Mid Term Transfer, will have to report to the Academy for their respective courses from the new place of posting, as per the present schedule only.
5. The participants have to report to the Academy on 09.00 A.M. sharp on due date of their training in proper dress.
6. The participant will be provided Hostel and mess facility.
7. Those officers who are conditionally liable to be exempted from training programme in view of above mentioned condition, an intimation must be sent in this regard to the Director, Bihar Judicial Academy, Patna by the concerned officers.
