The nominee A.D.Js., who have been promoted as Principal Judge (Family Court) as on the date of respective training, are not required to attend the training courses, meant for ADJs.

In case of any change in place of posting, is noticed in the attached list, the Participants have to attend the training as per the above schedule only, from their actual place of posting, under intimation to the Academy.

In case of any change in place of posting due to Annual General Transfer/Mid Term Transfer, the participants have to report at the Academy for their respective courses from their new place of posting, as per the above schedule only.


