Nominee Officers who have been designated as full time Secretary of District Legal Services Authority (D.L.S.A.) need not to attend their respective training as long as they hold such assignment.

The nominee A.D.Js., who have been promoted as Principal Judges (Family Courts) as on the date of their respective trainings, are not required to attend the training courses, meant for ADJs.

In case of any change in place of posting, is noticed in the attached list, the Participants have to attend the training as per the above schedule only, from their actual place of posting, under intimation to the Academy.

In case of any change in place of posting due to Annual General Transfer/Mid Term Transfer, the participants have to report at the Academy for their respective courses from their new place of posting, as per the above schedule only.

The participants should not fix the record on their scheduled date of the training.

The participants have to report to Bihar Judicial Academy at 09:30 A.M. sharp on due date of their training in proper dress.

The participants will be provided Hostel and Mess facility.

This is for information to All the District & Sessions Judges of Bihar and they are hereby requested to communicate the same to the Judicial Officers concerned for their respective Judgeship and they are also requested to ensure participation of all the nominees concerned accordingly.
