The nominee officers who are under suspension or joined special post as on the date of their training courses, are not required to attend the training.

The nominee Officers who are going to retire within one year from the scheduled date of training need not require to attend the training.

Nominee Officers who have been designated as full time Secretary of District Legal Services Authority (D.L.S.A.) need not to attend their respective training as long as they hold such assignment.

The nominee A.D.Js., who have been promoted as Principal Judges (Family Courts) as on the date of their respective trainings, are not required to attend the training courses, meant for ADJs.

In case of any change in place of posting, is noticed in the attached list, the Participants have to attend the training as per the above schedule only, from their actual place of posting, under intimation to the Academy.

In case of any change in place of posting due to Annual General Transfer/Mid Term Transfer, the participants have to report at the Academy for their respective courses from their new place of posting, as per the above schedule only.

The participants should not fix the record on their scheduled date of the training.

The participants have to report to Bihar Judicial Academy at 09:30 A.M. sharp on due date of their training in proper dress.

The participants will be provided Hostel and Mess facility.

This is for information to All the District & Sessions Judges of Bihar and they are hereby requested to communicate the same to the Judicial Officers concerned for their respective Judgeship and they are also requested to ensure participation of all the nominees concerned accordingly. Also, the directions contained in the aforesaid letter of the Hon'ble Court, have to be followed by the participants.

1. The Additional District and Sessions Judges, who get promoted as Principal Judge, Family Court on or before the date of their respective training, are not required to attend the above training.
2. The participating officers who are under suspension or joined special post as on the date of their training, are also not required to attend the aforesaid training.
3. The officers, who have been designated full time secretary of District Legal Services Authority, are also not required to attend the aforesaid training as long as they hold such post.



4. The participating officers who are due to retire within one year from the date of their respective training are also not required to attend the training.
5. In case of Annual General Transfer / Mid Term Transfer, the officers have to report at the Academy for their respective courses from the new place of posting, as per the present schedule only.
6. The judicial officers concerned must not fix the record on the scheduled date of their training.
7. In case of collision of the aforesaid training at BJA with any other training outside the State i.e. at National Judicial Academy, Bhopal & LNJN National Institute of Criminology & Forensic Science, Delhi etc., the officers concerned are exempted from participation in the training at the BJA, though an intimation to this effect must be sent by such officer(s) to the Bihar Judicial Academy.
8. The participants have to report to the Academy on 09.30 A.M. sharp on due date of their training in proper dress.
9. Hostel facility and mess facility will be provided to the participants.

This is for information & immediate communication to the District and Sessions Judges to ensure participation of all the participants aforesaid accordingly.
