As per the directions of the Hon'ble High Court, lists of Judicial Officers spared for Orientation/Refresher Courses scheduled to be held from month of July to September, 2018 is annexed herewith as annexure I to X and Judicial Officers spared for Special Trainings are as mentioned in the above table.

The nominee Officers who are going to retire within one year from the scheduled date of training need not require to attend the training.

The nominee officers who have joined special posts as on the date of their training courses, are not required to attend the training.

The Nominee Officers who have been designated as full time Secretary of District Legal Services Authority (D.L.S.A.) need not to attend their respective training as long as they hold such assignment.

Such nominee officers who are not required to attend training in the light of above stated facts, are requested to communicate the same to Bihar Judicial Academy prior to their respective training schedule.

The nominee officers who are under suspension as on the date of their training courses, are not required to attend the training.

The nominee A.D.Js., who have been promoted as Principal Judges (Family Courts) as on the date of their respective trainings, are not required to attend the training courses, meant for ADJs.

In case of any change in place of posting, is noticed in the attached list, the Participants have to attend the training as per the above schedule only, from their actual place of posting, under intimation to the Academy.

In case of any change in place of posting due to Annual General Transfer/Mid Term Transfer, the participants have to report at the Academy for their respective courses from their new place of posting, as per the above schedule only.

The participants should not fix the record on their scheduled date of the training.

The participants have to report to Bihar Judicial Academy at 09:30 A.M. sharp on due date of their training in proper dress.

The participants will be provided Hostel and Mess facility.

This is for information to All the District & Sessions Judges of Bihar and they are hereby requested to communicate the same to the Judicial Officers concerned for their respective Judgeship and they are also requested to ensure participation of all the nominees concerned accordingly. The aforesaid participants be instructed / intimated as under:

1. The Additional District and Sessions Judges who are promoted as Principal Judge, Family Court on or before the date of their respective training, are not required to attend their respective training.
2. The participating officers who are under suspension or joined special post as on the date of their training, are also not required to attend the aforesaid training.
3. The officers, who have been designated full time secretary of District Legal Services Authority, are also not required to attend the aforesaid training as long as they hold such post.
4. The participating officers who are due to retire within one year from the date of their respective training are also not required to attend the training. Though, this criterion is not applicable in case of the District and Sessions Judges.
5. In case of Annual General Transfer / Mid Term Transfer, the officers have to report at the Academy for their respective courses from the new place of posting, as per the present schedule only.



6. The judicial officers concerned must not fix the record on the scheduled date of their training.
7. In case of collision of the aforesaid training at BJA with any other training outside the State i.e. at National Judicial Academy, Bhopal & LNJN National Institute of Criminology & Forensic Science, Delhi etc. as per nomination by this Court, the officers concerned are exempted from participation in the training at the BJA, though an intimation to this effect must be sent by such officer(s) to the Bihar Judicial Academy.
8. The participants have to report to the Academy at 09.30 A.M. sharp on due date of their training in proper dress.
9. Hostel facility and mess facility will be provided to the participants.

This is for information & immediate communication to the District and Sessions Judges to ensure participation of all the aforesaid participants aforesaid accordingly.
