Following directions have been given by Hon'ble Court vide above referred letter to the participants for above mentioned Training Courses:-

1. The participating officers who are under suspension or joined special post as on date of their training, are not required to attend the aforesaid training.

2. The Nominee Officers who have been designated as full time Secretary of District Legal Services Authority (D.L.S.A.), are also not required to attend the aforesaid training as long as they hold such post.
3. The participating officers who are due to retire within one year from the date of their respective training are also not required to attend the training.
4. The Officers whose place of posting are changed till the date of scheduled training due to Annual General Transfer / Mid Term Transfer, have to report at the Academy for their respective courses from the new place of posting, as per the present schedule only.
5. The Judicial Officers concerned must not fix the record on the scheduled date of their training.
6. In case of collision of the aforesaid training at BJA with any other Special Training outside the state, i.e., at National Judicial Academy, Bhopal & LNIN National Institute of Criminology & Forensic Science, Delhi etc. as per nomination of the Hon'ble Court and also with the scheduled inspection of the judgeship, the officers concerned may be deemed to have been exempted from participation in their respective training at the BJA, though an intimation to this effect must be sent by such officer(s) to the Bihar Judicial Academy.
7. The participants have to report to Bihar Judicial Academy at 09:30 A.M. sharp on due date of their training in proper dress.
8. Hostel facility and Mess facility will be provided to the participants.
