



With reference to the above mentioned subject, I would like to submit before your goodself that vide letter no.- 2835/2017/Computer Cell, dated 17.01.17 of Hon'ble High Court, for fixing the date of training for the target group of newly recruited eight ADJs from Bar (Seven Days), All Judicial Officers of 28th Batch of BJS (Seven Days), Nodal Officer of each Judgeship (Two Days) and System Officers of each Judgeship (Two Days).

3. Nodal Officer of each Judgeship (Two Days)- 12th & 13th April,2017.


4. System Officers of each Judgeship (Two Days)- 12th & 13th April,2017
